6. To receive responses concerning the draft Development Boundary received since the start of the 6 week statutory pre-submission consultation and to decide whether any changes should be made to the Boundary using the three eligibility criteria already approved.

6(a) To consider responses to the inclusion part of the land comprising the original cell 4 (former Golf Club land NE of Cott Rd) within the proposed Development Boundary (See attached responses, map and photos).

6(b) To Consider the response to the exclusion of the land adjoining 'Meanders', St Nicholas Park (part of cell 29) and report of the site meeting (See attached comment from the owner).

6(c) To consider the response to the exclusion of cell 23 (land to the SW of the Old Orchard, Castle Hill (see attached response from Andrew Beard and photographs).

6(d) To consider the response asking that land to the South East of Pill cottages should be included. This is immediately to the South East of cell 17.

6(e) To consider the response asking that the Eastern part of Cell 8 be included within the Development Boundary.

6(f) To consider the response asking that the field bordering Tanhouse Rd and to the North West of cell 29 be included within the Development Boundary.
