 Economic Plan prepared by one of the neighbouring areas. The Council
 agreed that the preparation of a list of economic projects up to the year 2030
 should be included as part of the work of the Neighbourhood Development
 Plan working party. Members agreed to suggest items for inclusion, these
 suggestions to include community based and not just Council based projects.
- c) It was proposed by Councillor Jewels and seconded by Honoured Burgess
 Peareth that expenditure for the printing of the Transport newsletter —
 Newsletter 3 is approved subject to the removal of part 3 of draft question 12
 and the clerk proof reading the document prior to printing. This proposal
 received the support of the Council.


