NPSG73/25 Apologies

NPSG66/25 Meeting Minutes 17 September 2025

It was **resolved** that the minutes of the NPSG Meeting held on 17 September 2025 are accepted, approved and duly signed by the Committee Chair Martin Surgey.

NPSG77/25 Cycle route update

It was agreed to ask Council to issue letter 4 after the heading had been modified to read 'Duchy of Cornwall land'. The clerk confirmed that if approved by Council the letter will be addressed to Luke Humphries, Cornwall Land Steward.

NPSG78/25 NPS – Employment & Economy section – Business survey

The Steering Group expressed their disappointment that only 8 responses had been received. However, the views expressed by those businesses that did respond were broadly in agreement with the opinions expressed in the town wide survey. Parking came through very clearly as the most significant issue.

NPSG79/25 NPS – Maps

Conservation area – the group liked the presentation of this map but would ask if it would be possible to add the names of the main streets. E.g. Fore Street, Quay Street and the streets on the perimeter of the Conservation Area.

Employment area – the clerk was asked to ask if it would be possible to arrange a map of the town's employment area - the Industrial Estate, Fore Street, Queen Street and Quay Street.

Contours map – the group asked if it would be possible to change the colour scheme to perhaps paler shades/colours in order that the field boundaries would become more defined.

Transport Map & Parish Boundary Map – the clerk was asked to ask if it would be possible for the Parish Boundary to be a purple or thin black line rather than red. The group considered the use of red might be too confusing.

NPSG80/25 NPS – Submission format

It was decided that the group would broadly follow the simple plan template suggested by Cornwall Council.

- 1. Introduction
- 2. Parish today
- 3. Key data
- 4. Community survey
- 5. Vision, Objectives and Priorities
- 6. Appendices
- 7. Checklists

So, using the Employment section as an example some of the prepared text would be entered under Parish, some into Key Data and then a large percentage into Vision, Objectives & Priorities.

It was further explained that it is anticipated that the Community survey section, for example, will have 6 sub headings which reflect the 'topics' of the NPS.

NPSG81/25 AI – Presentation

Two group members did AI demos to illustrate the benefits of using AI to help draft NPS text and the final NPS document. It was agreed that a copy of the demo document would be circulated to Steering Group Members to facilitate further discussion at the next meeting.
